2. Add pesticides or fertilizer as directed.
3. Continue to fill with water until about 90% full.
4. Add Nanotek Surfactant. Fill sprayer to 100% full.

## FIRST AID

**STORAGE:** Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool, and well-ventilated area, away from incompatible materials and food and drink. Keep container closed. Do not store below 4°C as product will freeze.
